Fitness & Aerial Classes

General

Faye Body Fit fitness & Aerial classes are offered as PAYG (Pay As You Go), unless otherwise stated.

Aerial classes refer to Pole Fitness and Pole Silks classes, as listed on my website.

I ask that you arrive on time for your class as late arrival may result in you being refused entry. This is at the discretion of the Instructor and in such an event, no refunds will be given.

Booking & Payment

All classes can be booked via my website https://www.fayebodyfit.co.uk/.

I currently allow booking up to 3 months in advance. Payments are required online at the point of booking to secure your space. Card payments and Paypal are accepted.

If the class you require is fully booked, you can request that your name is added to a waiting list and you will be contacted should a space become available. Please be aware that there is no priority system on the waiting list. Once a space becomes available ALL those on the waiting list will be notified and places will be allocated on a first come, first served basis.

Please be aware that a Health Questionnaire must be completed ahead of your first class. If you answer YES to any of the questions within the Health Questionnaire, I reserve the right to defer your booking whilst you seek medical guidance before participating in a Faye Body Fit fitness or aerial class.

Terms & Conditions

Pricing Plans

Pricing plans allow you to pay upfront for a block of sessions which you can then redeem against Faye Body Fit classes. Once a pricing plan has been purchased, it is YOUR responsibility to book your classes.

At the point on purchase, the plan will highlight any terms and conditions. Each pricing plan is valid for a set period. The start date will begin from the **date of purchase** and must be used for classes during the time for which it is valid.

Pricing plans cannot be extended and any sessions remaining after the expiry date cannot be transferred or refunded.

Pricing plans can only be used by the person for whom it has been purchased and cannot be shared between participants.

My cancellation policy applies to all classes booked using a pricing plan.

Cancellation Policy

If you wish to cancel your class booking ahead of the class start date, a full refund will be given providing **24 hours' notice** (from the start of your class) has been given, or your booking can be transferred to another date.

If you request to cancel your class booking with **less than 24 hours**' notice (from the start of your class) the class fee still applies, without deference or transfer.

If you do not receive confirmation of your cancellation, assume Faye Body Fit has NOT received your request which may affect your refund. It is YOUR responsibility to follow up on your request.

I will endeavour to provide as much notice as possible should a class need to be rescheduled. Where a pricing plan has been used to purchase the class, an extension will be granted to ensure the expiry date is not jeopardised.

Absolutely no alcohol or illegal drugs can be taken whilst present at a Faye Body Fit class. If there is evidence to suggest you have taken such substances, or you behave in a matter which implies you have done so, you will be removed from the class or event and will forfeit any monies paid.

Abuse will not be tolerated to any of the Instructors, Event Professionals or other Participants. If this occurs you will be asked to leave the premises and will forfeit and monies paid for the class or event.

If you see another Participant performing a 'trick' you have not yet learnt, please refrain from trying this yourself and wait for an Instructor.

Booking & Payment

Terms & Conditions

Faye Body Fit Personal Training can be purchased as single or a block of sessions. A personal training session can be booked by contacting Faye Body Fit directly, or via my website booking system: https://www.fayebodyfit.co.uk/personal-training.

Payment is required IN FULL in advance of your session. When multiple sessions are book, you must be in credit of one session at all times.

Payment can be made via cash or BACS, or via credit/debit card or Paypal via my website.

Sessions will begin promptly. If you are late for your appointment the session will conclude at the original finish time - no time will be added on at the end.

Cancellation Policy & Refunds

At least **24 hours' notice** (from the start of your session) must be given if you wish to cancel a personal training session.

Any personal training sessions missed or cancelled with less than 24 hours notification are forfeited in full, without deference or transfer.

You must contact Faye Body Fit directly to cancel your booking. Contact details can be found on our website: https://www.fayebodyfit.co.uk/. Confirmation of your request will be provided by Faye Brownjohn, Owner of Faye Body Fit. If you do not receive confirmation of your cancellation, assume Faye Body Fit has NOT received your request which may affect your refund. It is YOUR responsibility to follow up on your request.

All items are inclusive of standard UK VAT.

Shipping and Delivery

Standard shipping to UK is included with all prices. Please allow 10 working days for delivery of your order. However, shipping and delivery times may vary depending on stock levels and postal peak periods.

Faye Body Fit does not currently deliver outside of the United Kingdom.

Returns and Replacements

Under the Consumer Contracts Regulations, Faye Body Fit is happy to exchange or refund your purchase should you not be entirely satisfied with your goods. You must cover the cost of the return postage for returns or exchanges, exchange items will be posted back out to you free of charge.

Exchange/refunds will only be given provided the items returned have not been worn, washed or damaged in any way and are returned in their original packaging.
